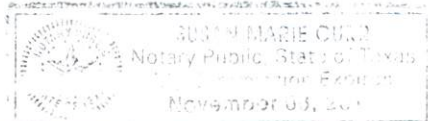

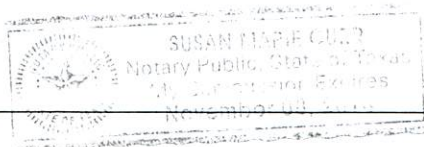

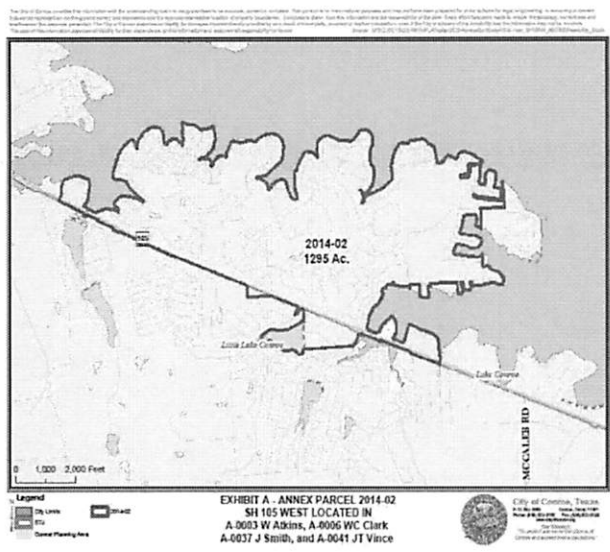

**NOTICE OF PUBLIC HEARINGS ON SH 105 WEST
ANNEXATIONS
BY THE CITY OF CONROE**

The City Council of the City of Conroe, Texas will conduct two public hearings to receive public comment on the proposed three year plan annexation of the following described territory to be incorporated within the boundaries of the City of Conroe:

Annexation Parcel No. 2014-02, 1,295 acres of land, more or less, out of the William C. Clark Survey (A-0006), William Atkins Survey (A-0003), James Smith Survey (A-0037) and John T. Vince Survey (A-0041) in Montgomery County, Texas, said territory being located in the general vicinity north/northwest of the intersection of State Highway 105 West and Tejas Boulevard and including Montgomery County Utility Districts (MUDs) 3 and 4 and the April Sound Subdivision.
