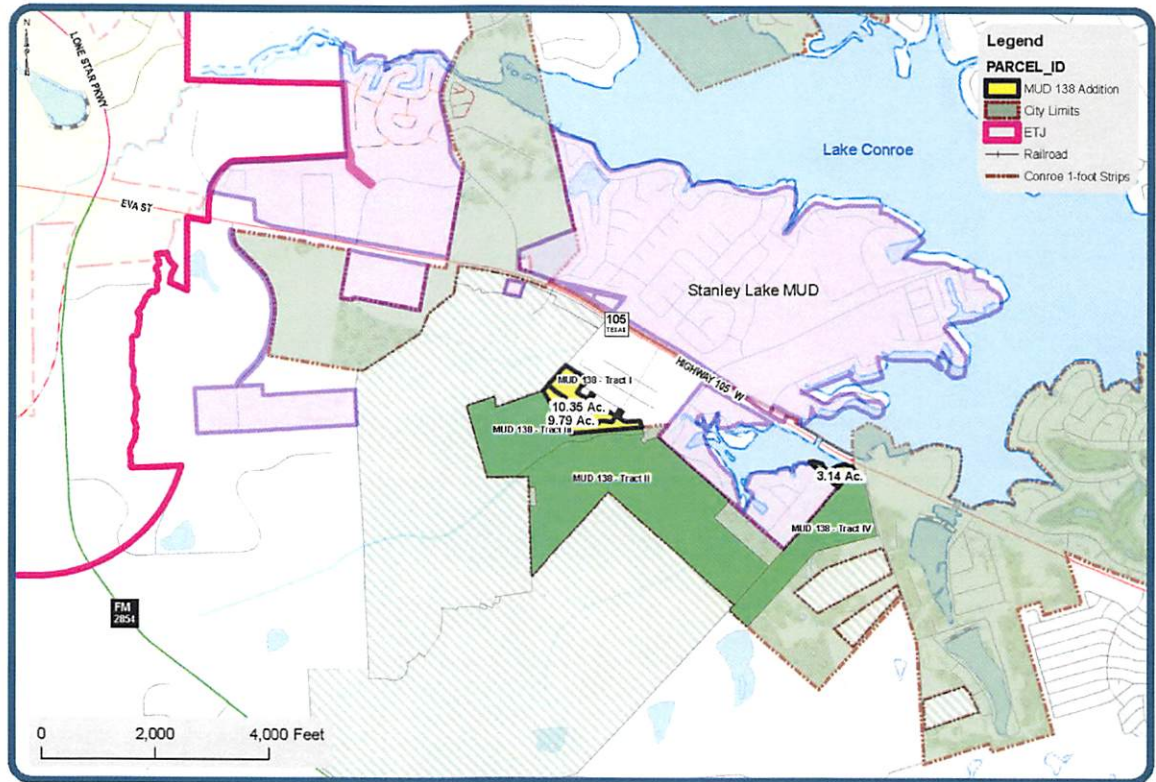


**NOTICE OF PUBLIC HEARINGS ON ANNEXATION

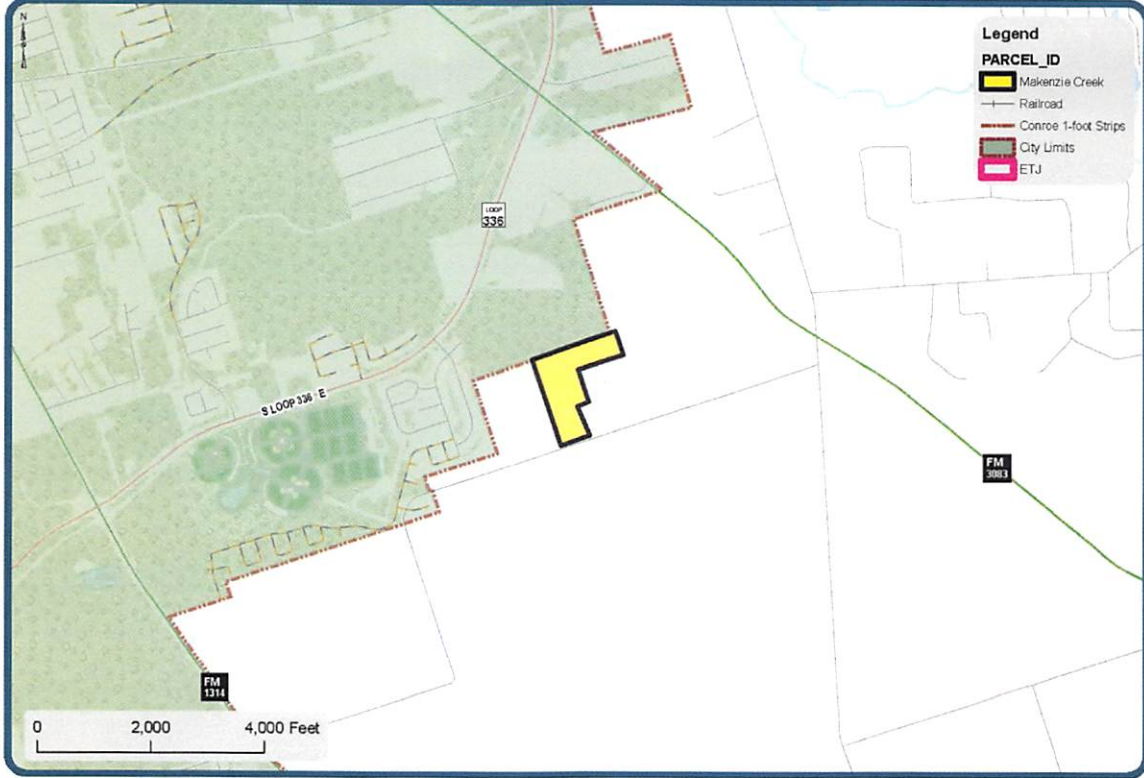

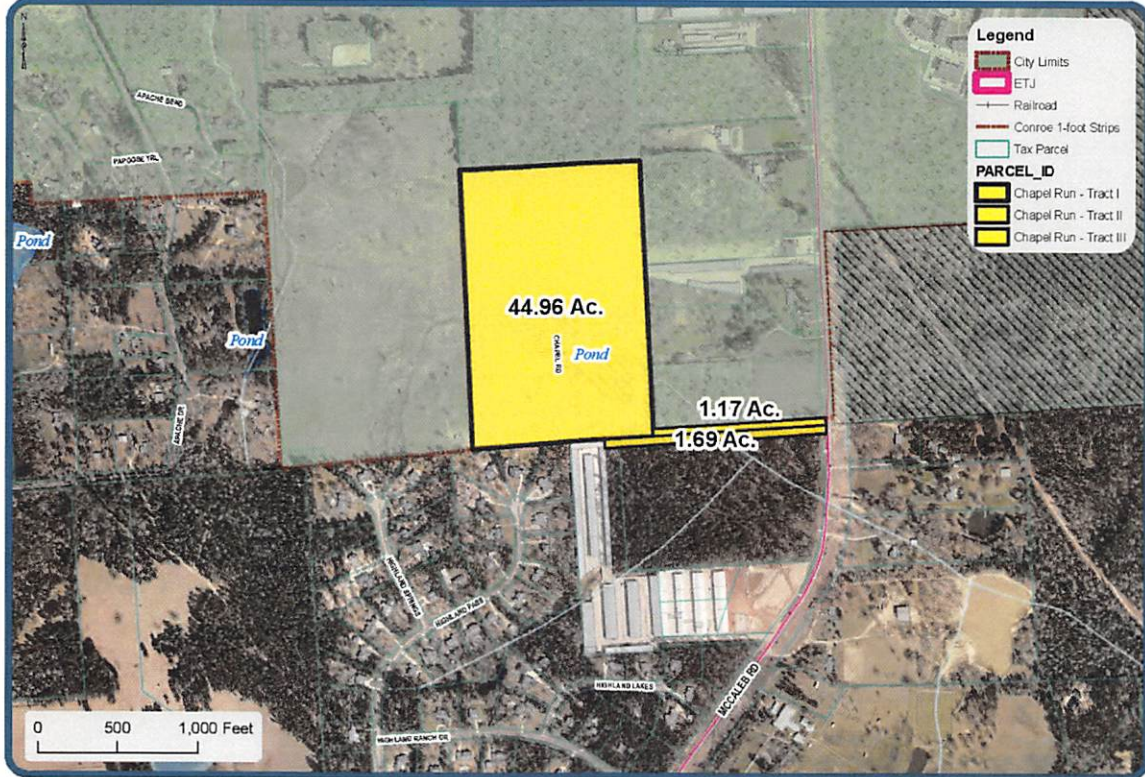
